




Professional Placement for Job Seekers (Magang) Program (1)

- Survey on acceptance status of Professional Placement for Job Seekers (*Magang*) Program based on Regulation
 of the Minister of Manpower of the Republic of Indonesia, Number 6 of 2020.
- Among respondent companies, 26% accept Magang for Job Seekers, and approximately 30% including the company that plan to implement it.

Implementation Status of Professional Placement for Job Seekers (Magang) Program







 About 80% of the companies accepting Magang program for Job Seekers are in manufacturing industry.

Insurance, distribution, investment, food and commodity, retail, banking, consulting industries: 1 company






Professional Placement for Job Seekers (Magang) Program 2

Number of Future Acceptance









Professional Placement for Job Seekers (Magang) Program 3

Number of Japanese companies (1569 companies) accepting Magang for Job Seekers.








(Q) Necessary things to spread more awareness about Professional Placement for Job Seekers Program (multiple answer allowed)







Professional Placement for Job Seekers (Magang) Program (5)

(Q) Do you know about Apprenticeship Manual?









Internship Program for College and High School Students 1

Internship Acceptance






- Accepting interns from high school and college students.

Internship Program for College and High School Students 1 -2 (Industry Analysis)

About 60% of the companies accepting interns are in the manufacturing industry. Compared to *Magang* program for Job Seekers, a larger percentage of companies accept interns from industries other than the manufacturing industry.



Manufacturing Companies: 46 companies
(18 companies are automotive-related)
Trading company: 5 companies
Consulting company: 4 companies
Logistic company: 3 companies

Chemical, retail, insurance, trading, travel agent, IT service companies: 2 companies

Pharmaceutical, investment, distributor, outsourcing, banking, food and commodity, temporary personnel business: 1 company

The 46 manufacturing companies are based in Jakarta (13), Bekasi (6), Cikarang (21), Karawang (13), Purwakarta (3), Serang (3), Tangerang (2), Bandung (2).


Over 90% of the 31 non-manufacturing companies are based in Jakarta.



Plan to Accept Internship








Internship Program for College and High School Students 3

Number of interns in Japanese Companies (1569 companies)








Certification of Qualification 1

 Among the respondent companies, only about 14% utilize the Indonesian National Skill Aptitude Standard for Vocational Skills (SKKNI).





Certification of Qualification 3

- A lot of companies implementing SKKNI for "superior/senior staff evaluation" and "salary increase and promotion" as their objective.
- Aside from SKKNI, some fixed number of companies implementing either other kinds of qualification programs (22 companies) or their internal competency programs (31 companies).
